If an Answer or other responsive pleading is filed by the Defendant in this case, the case will be taken off of the non-contested hearing docket and will be set for a pretrial and trial. In the event of that occurrence, a separate Order Scheduling Pretrial and Trial will be sent.

A failure to prosecute or comply with the Ohio Rules of Civil Procedure or the local rules of this Court will result in the Court dismissing this action on its own motion, after notice to counsel.

Any party ordered to pay support shall take notice that this order was given on the date herein, that the party or parties ordered to pay shall be subject to the withholding of a specified amount of his or her wages or other income or assets and that withholding shall continue until all support is paid in full.
