Hello,

I hope you are well! I am reaching out to request a correction on the record with respect to attorney Vera Eidelman's PHV (copied here) in Cooley v. Foreman Afroman (2023-0069). I believe one of our colleagues had corresponded with your office about the same at an earlier point. Attached here, the order admitted Vera Pro Hac Vice in this matter but mistakenly as co-counsel for the defendant. She was representing only the amici curiae the American Civil Liberties Union and the American Civil Liberties Union Ohio.

The Ohio's Attorney Services requested us to get this corrected at the earliest possible. The office asked us to ensure that the entry be corrected and an order issued that confirmed that Vera was counsel for amicus (and not co-counsel to the defendant) and further that her role and appearance was only linked to the amicus brief. Would you be able to assist in getting a correction to the record (attached here)? Thank you so much for your help and do let me know any issues or any further information or steps you need from us.
