These statements are not to be filed with the Clerk of Courts and will be maintained separate and apart from the case file.**

MEDIATION CONFERENCE

The mediation conference is hereby set for **August 26, 2015 at 9:00 a.m.** **PLEASE REPORT TO THE MONTGOMERY COUNTY COMMON PLEAS COURT, 41 N. PERRY STREET, ROOM 103,**

DAYTON, OHIO. Parties or party representatives with authority to settle must be present at the mediation conference. Each party shall be accompanied by the lawyer expected to be primarily responsible for handling the trial of the case. In the event parties or their attorneys do not attend the mediation conference or make a good faith effort to participate in the mediation process, the Court may impose appropriate sanctions.
