At time of sentencing the Court was provided information relating to Ohio Victim of Crime compensation pay out in this case. At that time the only specific economic loss noted was the \$808 paid for by Ohio Victim of Crime for funeral expenses.

Follow up with the Ohio Attorney General's Office confirmed that \$50,0000 was paid to the children of the deceased in this case, see attached. However, other than for the \$808 fee for the funeral, there was no record accounting for what specific expenses were incurred or paid out.

As such the State requests \$808 be ordered in restitution, to the Ohio Attorney General's Victim of Crime Compensation Fund.

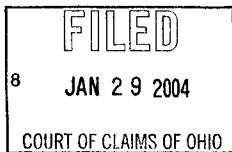

The applicants filed a reparations application seeking reimbursement of expenses incurred with respect to the July 28, 2001 murder of Shannon Anderson. On July 30, 2003, the Attorney General granted Nancy Anderson an award for funeral expense in the amount of \$808.00. The Attorney General also granted the decedent's minor children an award for dependent's economic loss in the amount of \$49,192.00 of which \$38,010.66 represents Alexandra's portion and \$11,181.34 represents Ambree's portion. On August 6, 2003, Nancy Anderson filed a request for reconsideration. On August 29, 2003, the Attorney General issued a Final Decision indicating that no modification of the previous decision was warranted and that the awards would be distributed once certified guardianship letters have been received. On September 9, 2003, Nancy Anderson filed an appeal of the Attorney General's Final Decision objecting to any distribution of the funds until guardianship has been resolved. Hence, this matter came to be heard before this panel of three commissioners on December 4, 2003 at 10:50 A.M.

Neither the applicants nor anyone on their behalf appeared at the hearing. An Assistant Attorney General attended the hearing and presented brief comments for this panel's consideration.

From review of the file and with full consideration given to all the information presented at the hearing, we find the August 29, 2003 decision of the Attorney General shall be affirmed.




- 1) The August 29, 2003 decision of the Attorney General is AFFIRMED;

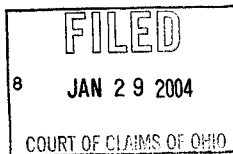

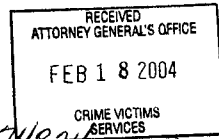

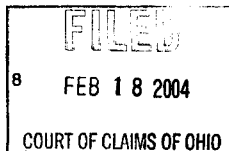

CONSOLIDATED FINAL DECISION OF THE ATTORNEY GENERAL

Dear Ms. Anderson & Ms. Brauchler:

This is to inform you that on **August 6, 2003**, we received Nancy Anderson's Request for Reconsideration. After careful review of the information you provided, the Attorney General finds that the previous Decision will not be modified. This decision is based on the following:

1. The Attorney General originally granted a maximum award in the amount of \$50,000.00. A funeral expense in the amount of \$808.00 has been processed for payment. The remaining amount of \$49,192.00 has been held pending review of the Request for Reconsideration and receipt of guardianship of the estate documents.
2. No one has disputed that the minor children are eligible and entitled to a crime victim compensation award as a result of the death of their mother. The request for reconsideration instead dealt with who oversees that money. However, the Attorney General's office has not made a decision as to that issue, only that the children are eligible for the money.

A local probate court would, instead, make the determination as to who supervises the children's finances, once someone petitions to become the "guardian of the estate" on their behalf. The Attorney General would then release the money to whomever the probate court selects.

3. Expenses were incurred as listed on the attached Expense Exhibit. Accordingly, the amounts totaling \$49,192.00, as listed on the attached Award Summary, will be paid at this time.


4. Payment of the award in favor of the decedent's minor children shall be held in abeyance until an adult person having guardianship over the child's financial affairs files certifies letters of guardianship of the estate, which can be obtained through the local county probate court.

If you do not agree with the Attorney General's final determination in this matter, you may file an Objection and Notice of Appeal with the Court of Claims of Ohio. Information regarding the appeal process has been included with this Final Decision.

Please be advised that an award is subject to repayment in the event that you receive payment for the same expenses from another person or entity.

We hope that this award will assist in your recovery. As already mentioned, if you incur additional expenses related to this claim, you may file a Supplemental Compensation Application. 
