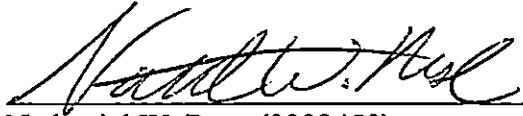

DECISION AND ENTRY AWARDING ATTORNEY FEES

This matter is before the Court on the issue of the amount of attorney fees to be awarded to the Plaintiff, Miami Township Board of Trustees. On August 30, 2022, this Court issued its Decision and Entry finding Defendant, Darren Powlette in contempt of court for violating this Court's Final Judgment; Injunction rendered on December 29, 2021. In addition to the monetary sanction imposed against Mr. Powlette in its August 30 decision, this Court also awarded Miami Township its attorney fees incurred in prosecuting the contempt action.

Counsel for the Township subsequently provided copies of the firm's itemized statements for legal fees to counsel for Mr. Powlette. On January 13, 2023, the Court conducted a telephone conference with counsel for both the Township and Mr. Powlette. During the conference counsel for Mr. Powlette informed the Court that he was not contesting the reasonableness of the fees, and as such there was no need for a hearing on the issue.

It is therefore hereby **ordered, adjudged and decreed** that the Miami Township Board of Trustees be awarded attorney fees in the amount of Nine Thousand Fifty Dollars (\$9050.00) against Defendant, Darren Powlette, plus statutory interest from the date of the filing of this Decision and Entry.
